Character.org assesses each application based on the following criteria:

1. The extent to which your initiative or program is unique, different, or in some way will contribute to the field of character development;
2. The extent to which your practice or initiative aligns with one or more principles articulated in our 11 Principles Framework for Schools; and
3. If your application narrative explains the impact of your practice or initiative (for students, staff, parents, community members, etc.).

Character.org does not give more than two designations to any one school or district applicant in a given year.

- **Character limits** – Are based on number of words which includes punctuation. Text that exceeds the character limits will not be included.
- **Applications in English only** – While we welcome applications from outside the United States, please note that we can only accept applications written in English.
- **Include a Photo** – You will be asked to upload a photo of your practice in action. Please read the PHOTO TIPS in the application carefully before you upload your photo.
- **Photo Release Policy** – If your photo includes young people, please be sure to follow your district's relevant policies for releasing photos since this photo may appear on Character.org's website, in publications and any recognition event (should your practice be selected).
- **Contact Information** – The contact and overview information provided in your application may appear on Character.org's website and publications (should your practice be selected).
- **Submitting your Application** – You may "save and return" to your application as many times as you wish until you click the "submit" button at the end of the application. Once the application has been submitted, it cannot be edited.
